The ETA encapsulates a suite of cloud computing solutions engineered by Arbo with the objective of autonomously monitoring, extracting, and aggregating transactional postings from a multitude of interstate natural gas electronic bulletin boards.

This report is designed to allow customers to visualize several different aggregations of the previous month's transactional postings, in order to identify trends, anomalies—and ultimately—opportunities.

We currently monitor the electronic bulletin boards of 46 pipelines and collect details on all capacity release and interruptible transactions being awarded. The scope of the report increases as ArbolQ's data engineering team continuously works to add coverage of additional pipelines.

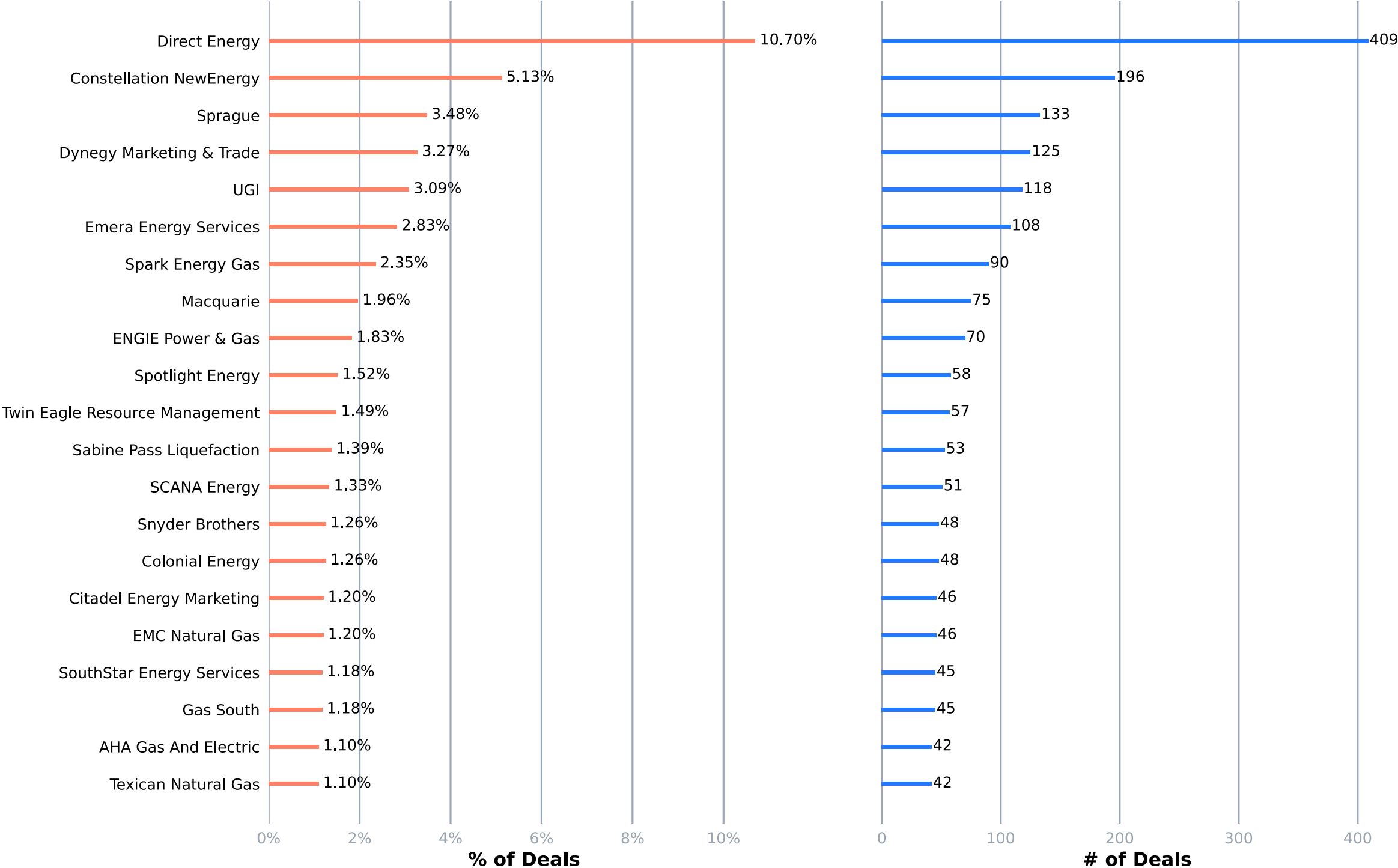

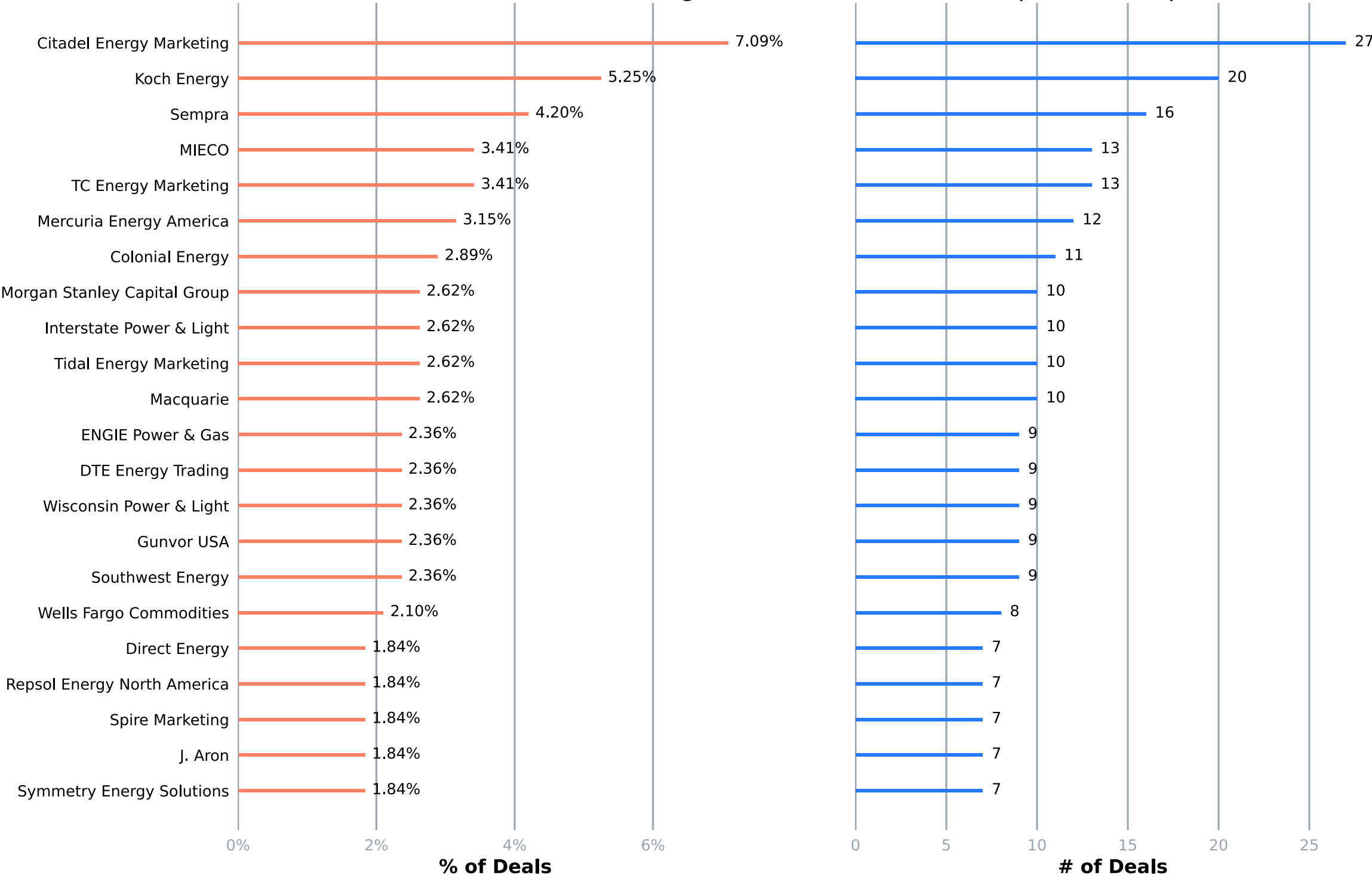

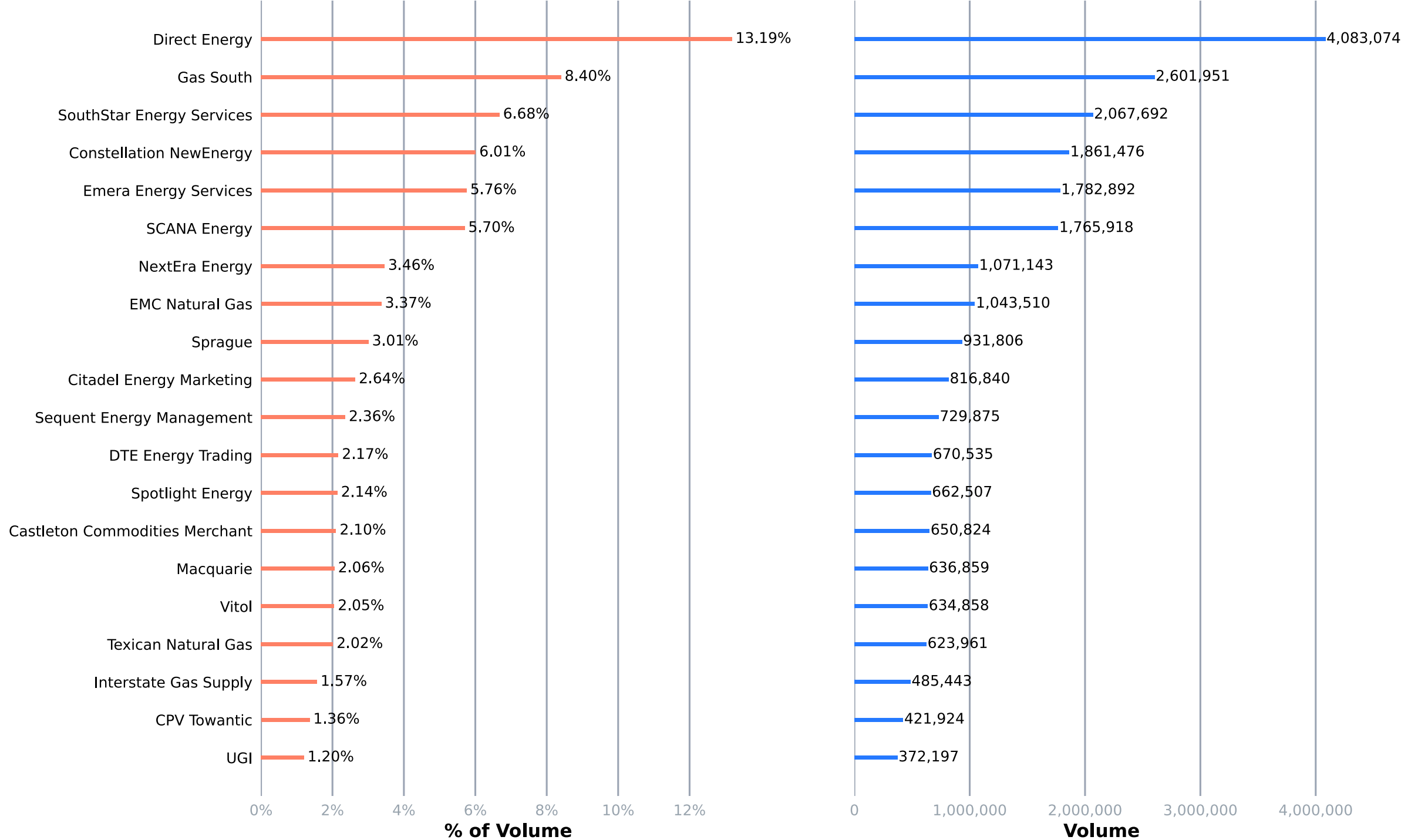
# Contract Holders: Number and Percentage of Total Deals for the Top 20 Capacity Release Contracts



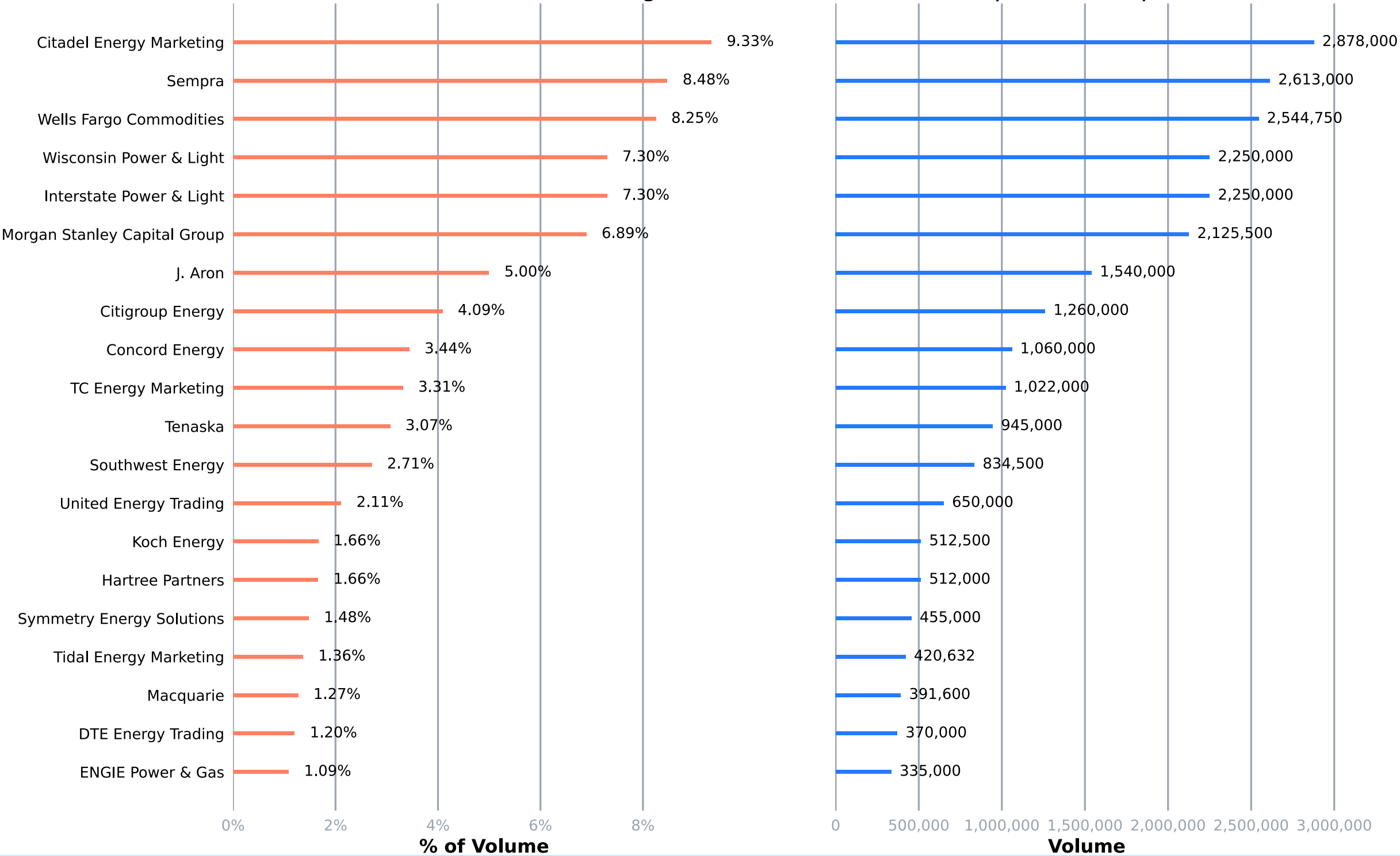
# Contract Holders: Number and Percentage of Total Deals for the Top 20 Interruptible Contracts



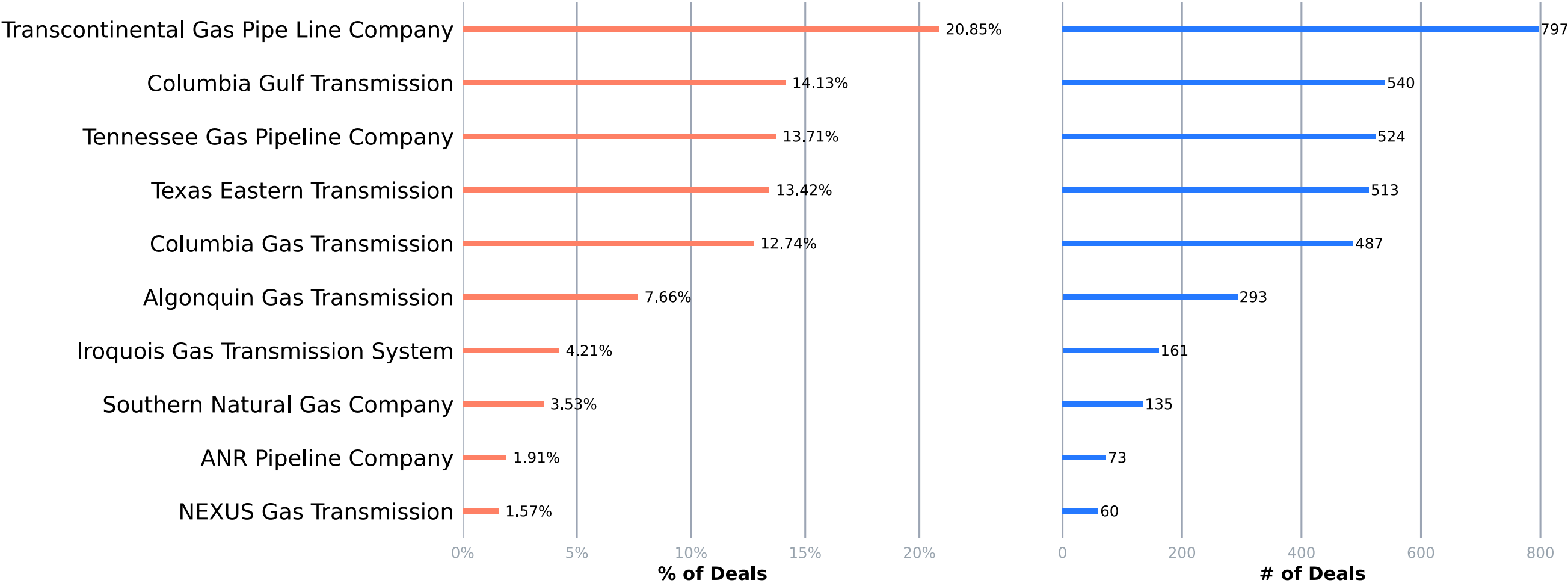
# Contract Holders: Volume and Percentage of Total Volume for the Top 20 Capacity Release Contracts

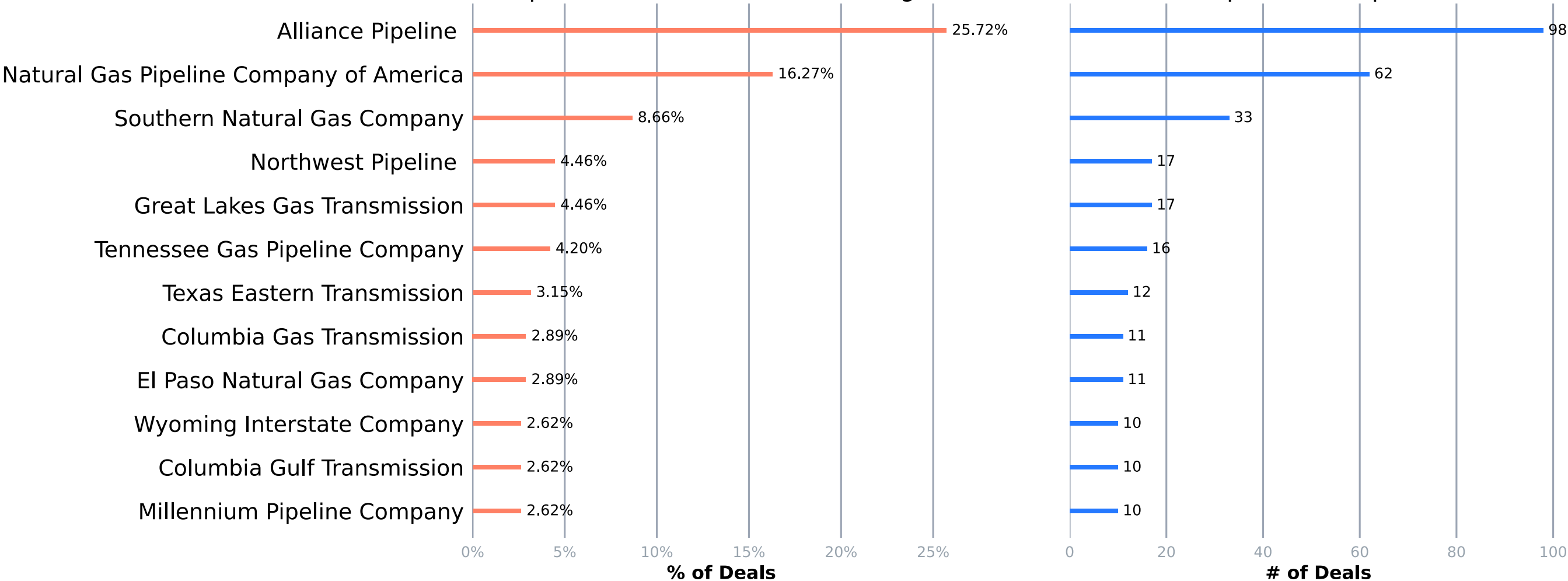


Pipelines: Number and Percentage of Total Deals for the Top 10 Capacity Release Contracts

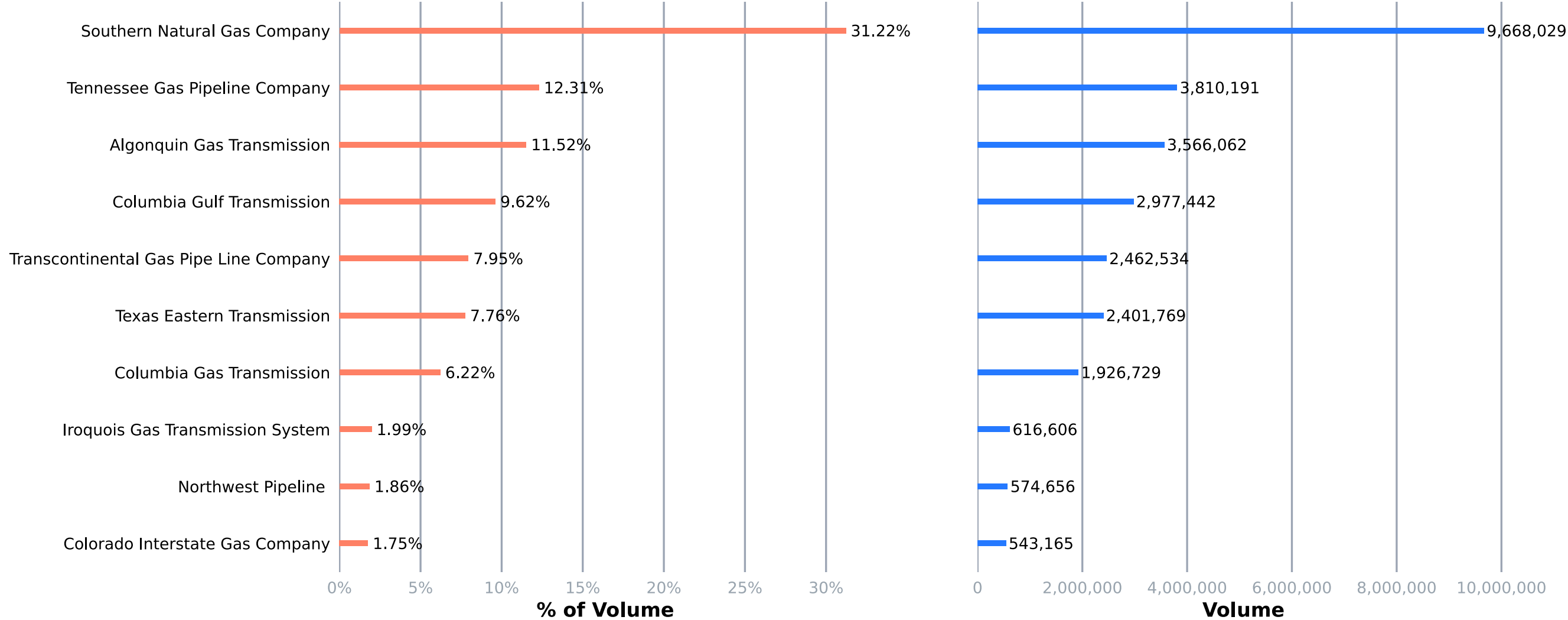




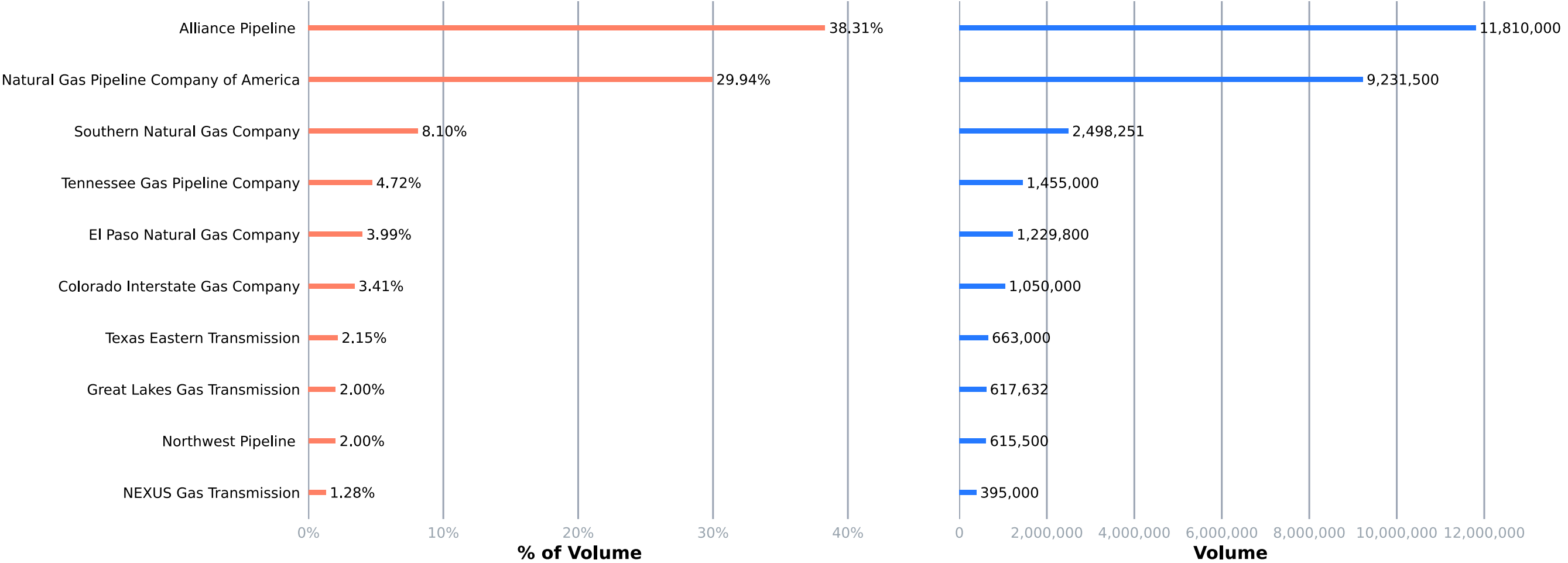
Pipelines: Number and Percentage of Total Deals for the Top 10 Interruptible Contracts



Pipelines: Volume and Percentage of Total Volume for the Top 10 Capacity Release Contracts



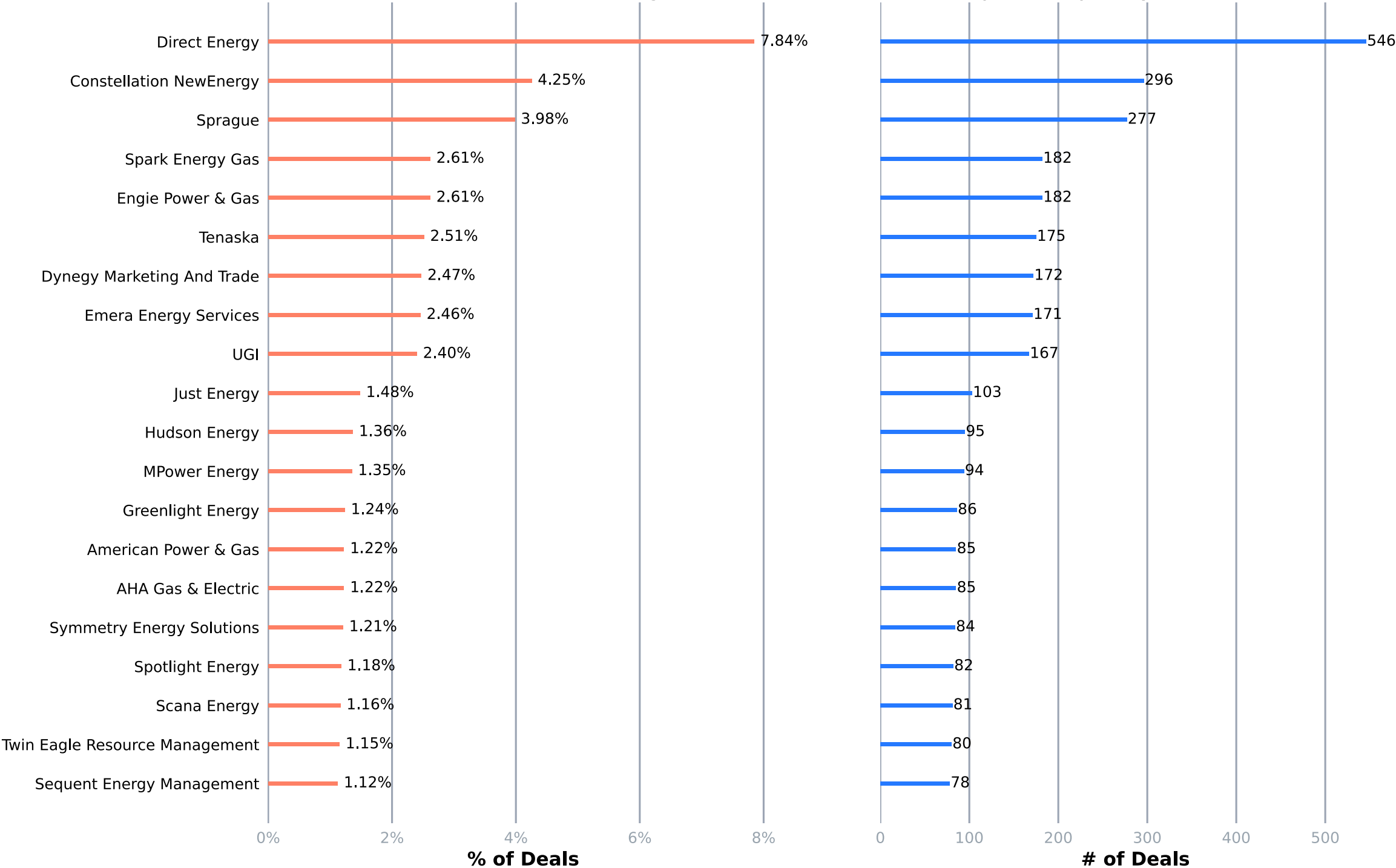

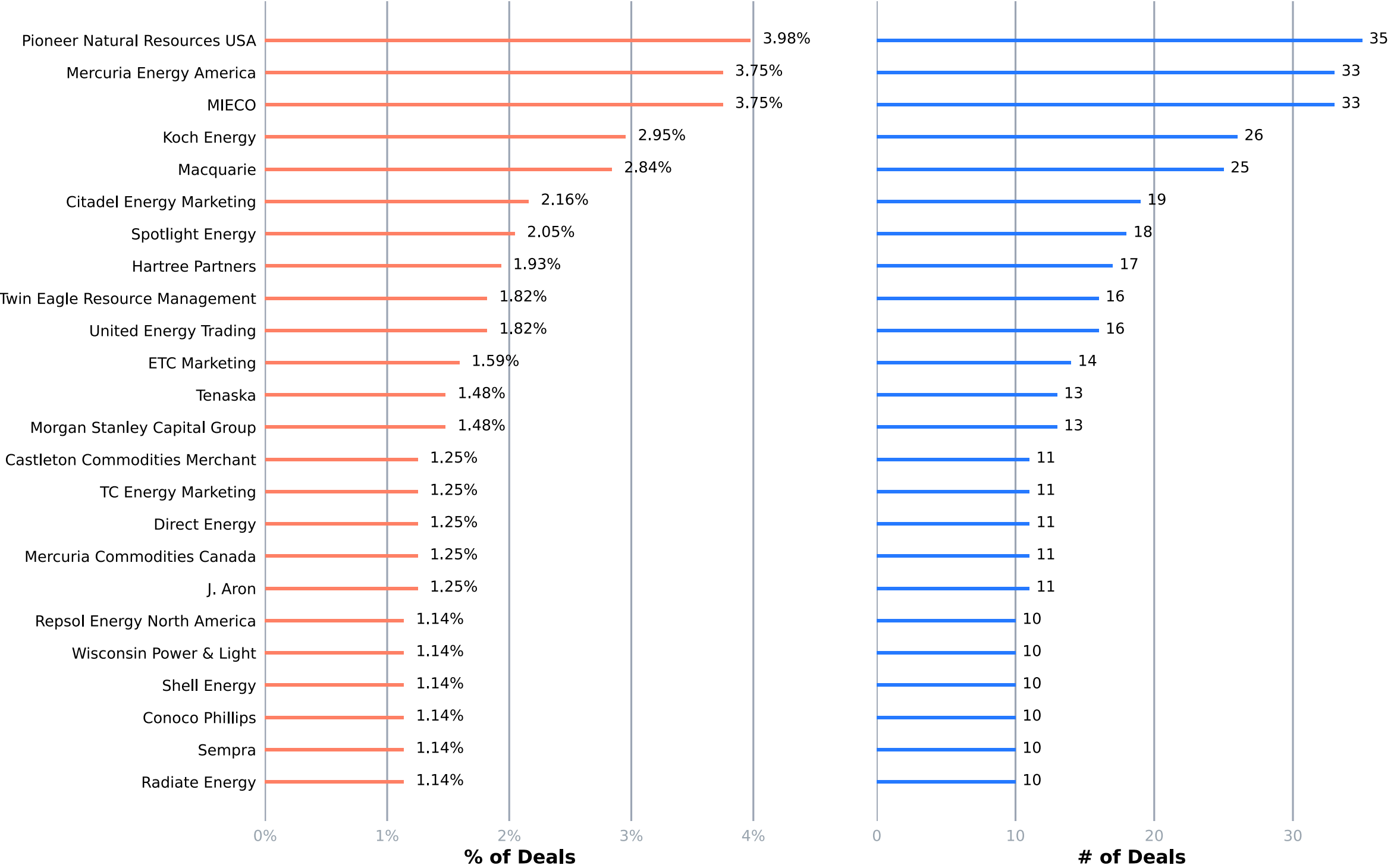

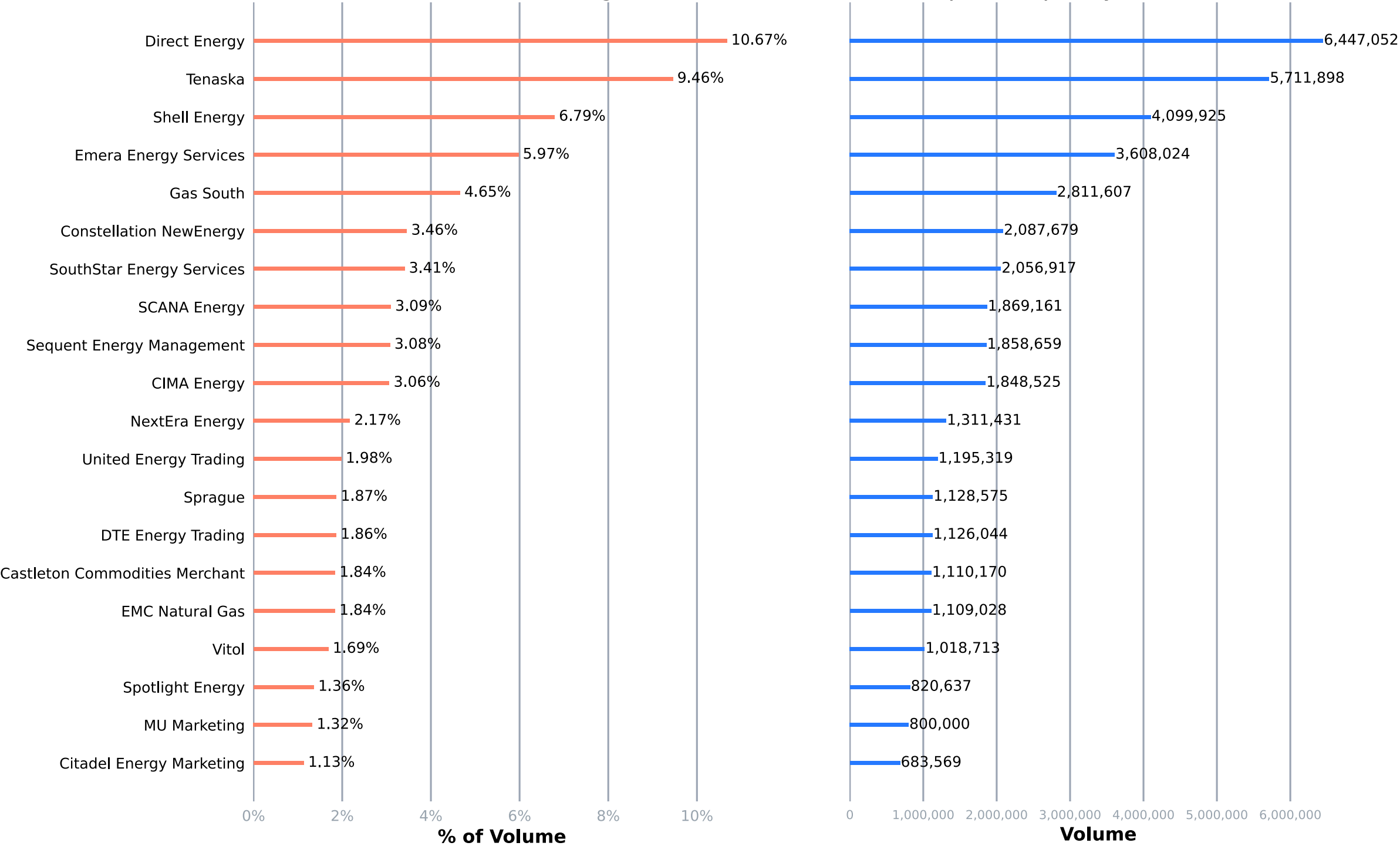
Contract Holders: Number and Percentage of Total Deals for the Top 20 Capacity Release Contracts



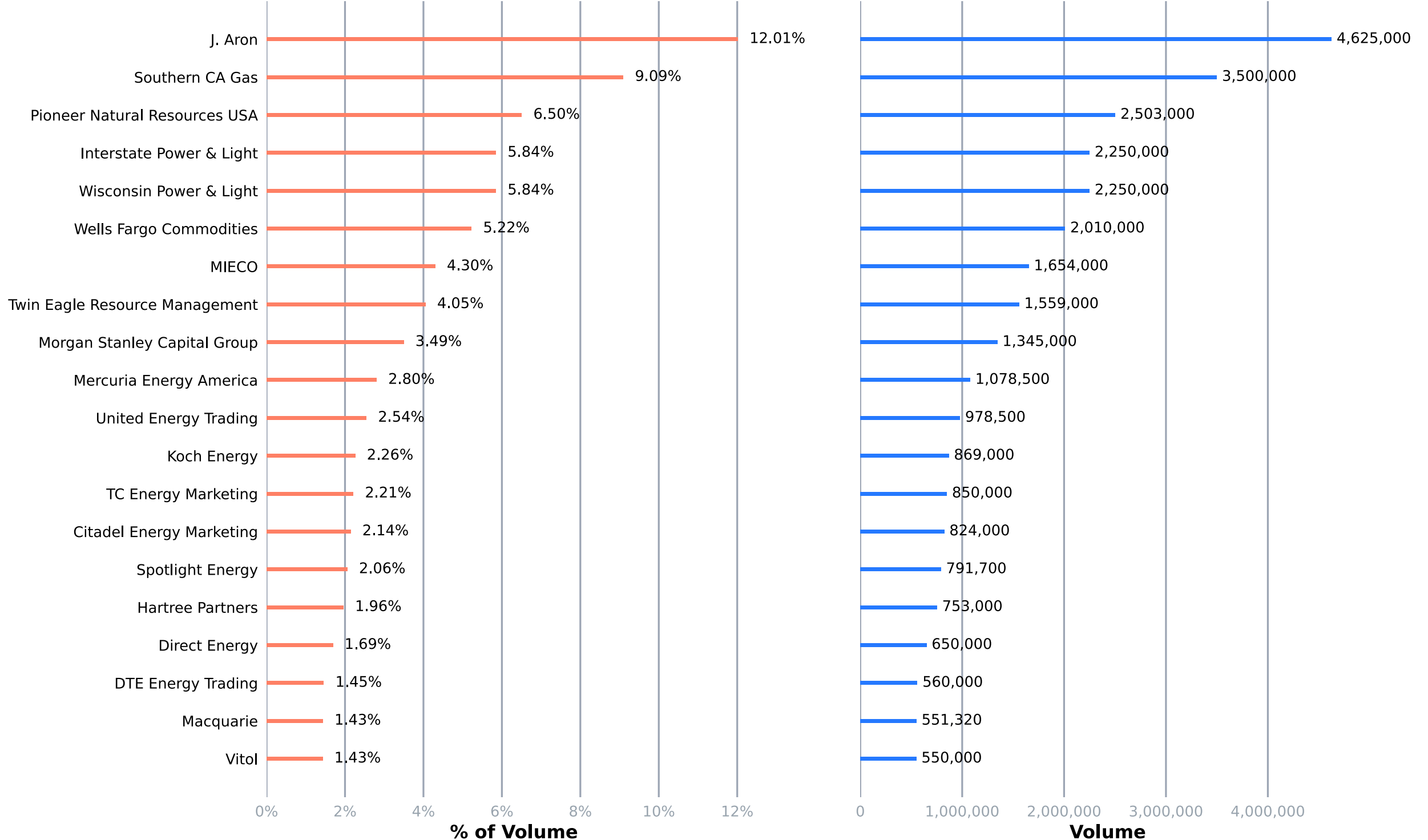
Contract Holders: Number and Percentage of Total Deals for the Top 20 Interruptible Contracts



Contract Holders: Volume and Percentage of Total Volume for the Top 20 Capacity Release Contracts

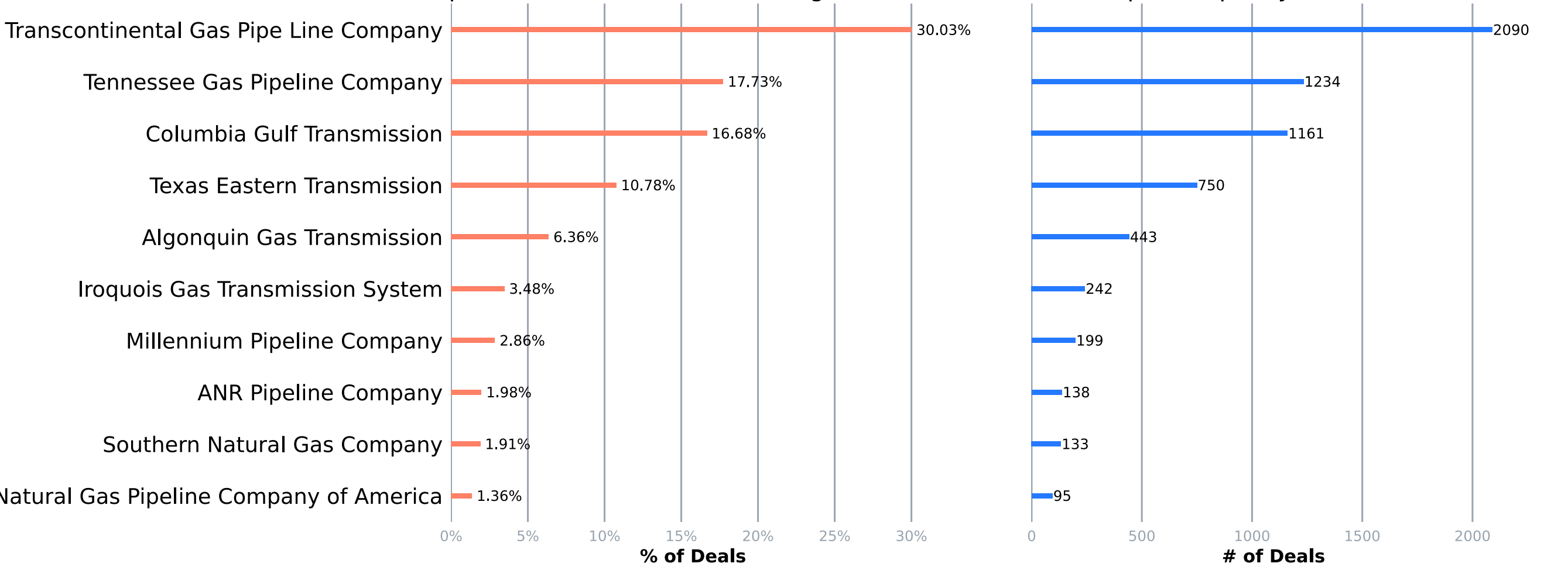

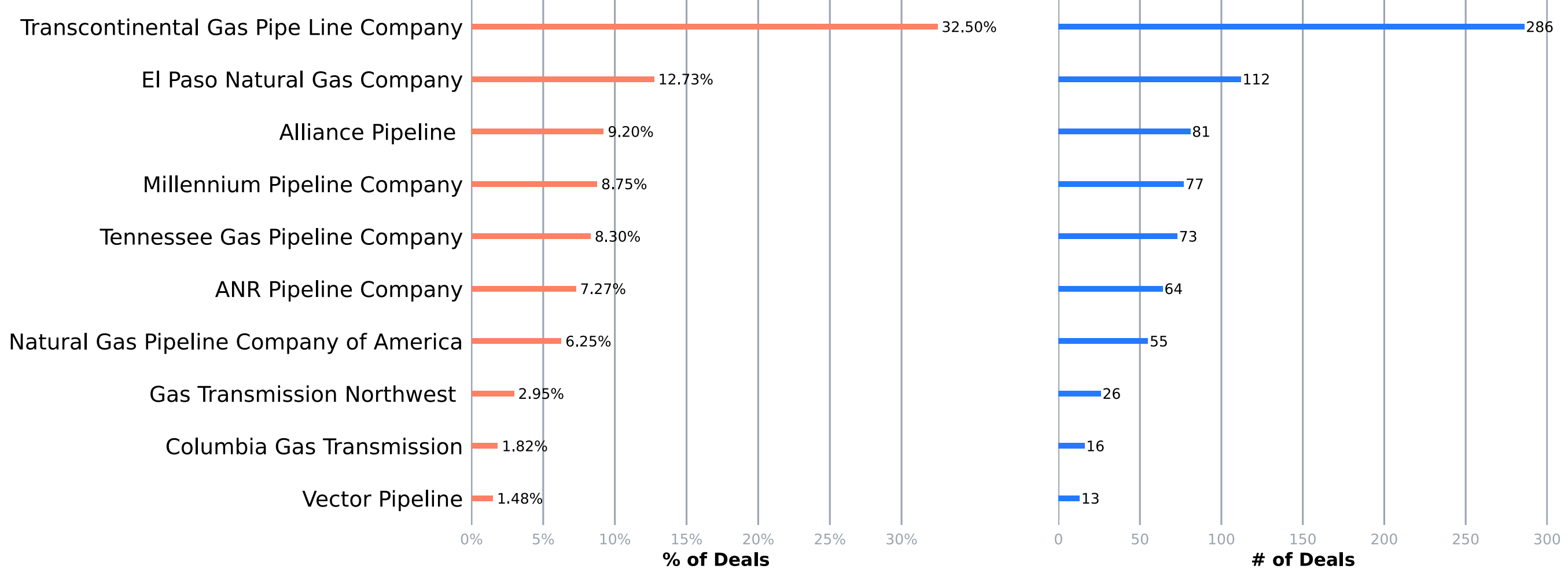




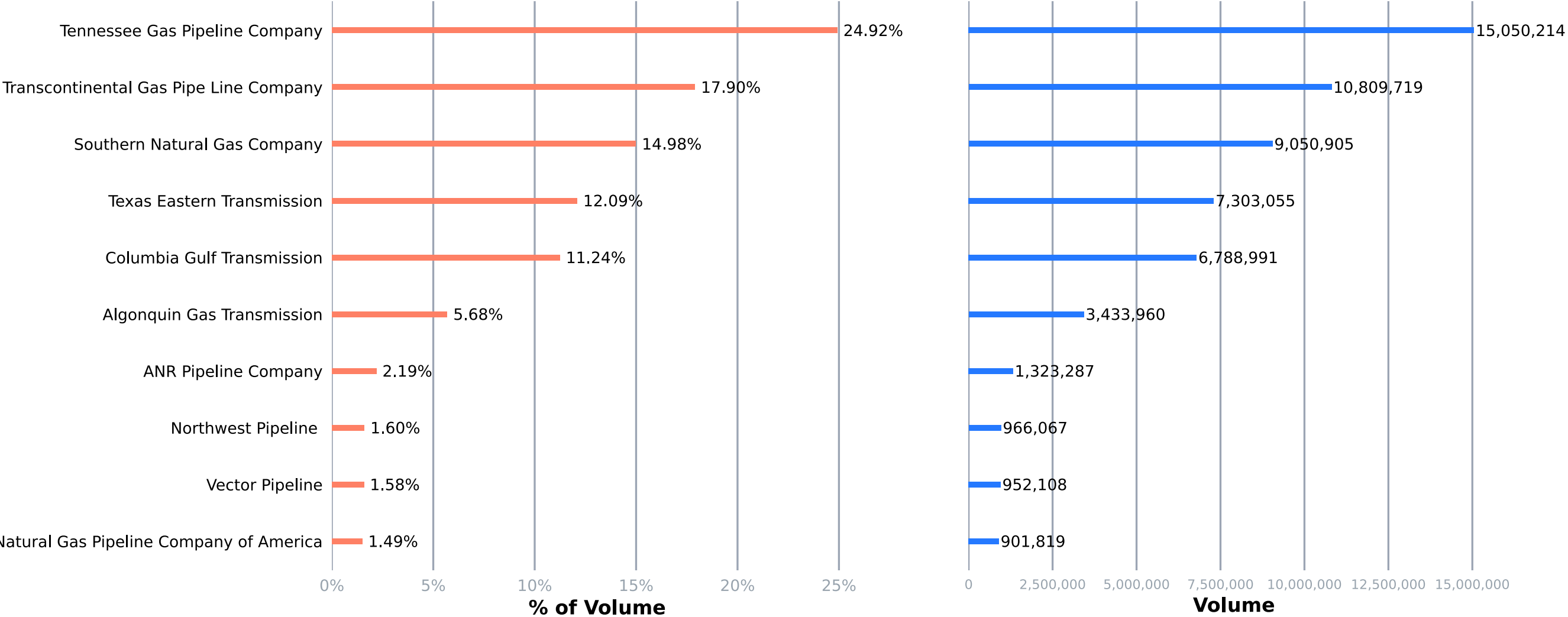
Pipelines: Number and Percentage of Total Deals for the Top 10 Capacity Release Contracts
